- In order to foster academic excellence and international cooperation, both faculties in Ss. Cyril and Methodius University in Skopje in Republic of North Macedonia (UKIM) and the Faculty of Regional Environmental Science in Tokyo University of Agriculture in Japan (Tokyo NODAI) agree to cooperate in the planning and implementations of scientific research, academic and educational programs. The parties express their interest in:
 - Joint scientific and research projects
 - Exchange of visiting academic staff
 - Exchange of students
 - Organization of joint scientific conferences and workshops
 - Exchange of publications, university editions, books and cooperation in communication networks
- The parties recognize that this Memorandum of Understanding establishes a foundation of mutual understanding and interest and does not in itself impose any obligations on either university. The parties concur that all financial arrangements necessary to implement this Memorandum of Understanding or any subsequent activity or agreement must be negotiated according to the regulations of each faculty and depend upon the availability of funds.
- All activities shall be in accordance with the regulations and policies of Ss. Cyril and Methodius University in Skopje and Tokyo University of Agriculture.
- The terms of cooperation for each activity implemented under this Memorandum shall be mutually discussed and agreed upon in writing by the parties involved prior to the initiation of that activity.
- This Agreement will be valid for 4 years, and will be extended unless termination is requested by one of the parties in a form of written notice 6 months prior to expiry. If one party wishes to terminate or revise this MoU before the expiration date, it has to give the other party a written notice at least 6 months in advance.

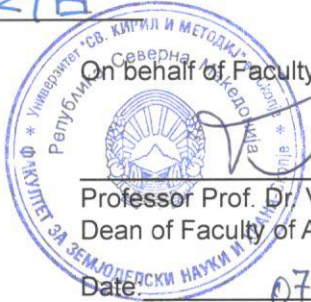
